SUBJECT: Map Release Schedule for Fiscal Year 2017

The Electronic Business (EBUS) Program Management Office at Transaction Services is publishing the production GEX map deployment schedule for FY2017. The schedule is an effort to standardize map deployments and to allow GEX customers to plan their requirements. The map developers will deliver map updates to the production sites in advance of the production deployment, as outlined below. The schedule is subject to change and updates to the schedule will be pushlished as necessary.

GEX customers are reminded that the only way to deploy customized maps to the GEX infrastructure is via Transaction Services approved developers. The most common way to obtain customized maps is via the GEX Indefinite Delivery Indefinite Quantity (IDIQ) contract vehicle. Please contact the GEX Program Manager with any questions.

Programs utilizing the GEX infrastructure to support their mission should utilize this schedule to plan for requirements. Emergency bug fixes for existing production maps must be coordinated with the GEX Program Manager for production deployment outside of the scheduled map deployments.

For new capabilities, out-of-cycle map deployments will be considered by the GEX Program Office on a case-by-case basis. Out-of-cycle approvals will be the exception. Program Managers will need to adequately document and justify any out-of-cycle production map deployments for approval by the GEX Program Manager. The justification should state why the program cannot deploy maps as part of a scheduled map deployment as outlined in the table above.
